HAMLET OF KUGLUKTUK

BY-LAW NUMBER 235

A By-law of the Municipal Corporation of the Hamlet of Kugluktuk in Nunavut to provide for the regulation and licensing of lotteries pursuant to the *Lotteries Act* R.S.N.W.T., 1988 Chapter L-11 and the *Hamlets Act*, R.S.N.W.T. Chapter H-1, S 169(a).

WHEREAS the Hamlet of Kugluktuk, under the authority of the *Hamlets Act* R.S.N.W.T. 1988 Chapter H-1, Section 169 (a) may provide for the establishment, levy and collection of charges for services provided by the municipal corporation including the issuing of licenses and permits,

NOW THEREFORE, the Council of the Hamlet of Kugluktuk, at a duly assembled meeting, enacts as follows:

ARTICLE 1 - SHORT TITLE

1.1 This By-law may be cited as the **Lottery By-Law**.

ARTICLE 2 - INTERPRETATION

2.1 No person, firm, partnership, company or society shall operate a lottery within the Hamlet unless a Hamlet of Kugluktuk Lottery License has been obtained pursuant to the Lottery By-Law.

2.2 An application for a license shall be made **AT LEAST ONE MONTH IN ADVANCE** of the scheduled event to the Senior Administrative Officer (SAO) in the form set out in Schedule "A" and shall include the following;

2.2(a) an application setting out the details of the lottery;

2.2(b) a declaration stating a person operating the lottery has not been convicted of an Act or its regulations to the operation of a licensed premise where an offence under the *Lotteries Act* R.S.N.W.T., the Criminal Code Part VII, the Liquor Lottery or, any other Act of the Territories or an Act of Canada, a province, the Nunavut Territory, Yukon Territory or the

Northwest Territories or a regulation made under these Acts, that demonstrates it is not in the public interest for that person to conduct a lottery scheme;

2.2(c) a fee as prescribed in Schedule B;

2.2(d) the fees prescribed in a single event bingo lottery or a series of bingo lotteries involves games which carry over jackpot amounts, only the amount of the opening jackpot shall be used to calculate the total value of prizes offered under Item 1 of Schedule "B" attached to this By-law;

2.2(e) if in the event, the applicant has previously received a license from the Hamlet Kugluktuk, the financial statements of the previous lottery if such record has not been returned.

2.3 Upon being satisfied that an applicant is in compliance with this By-law and that the application is in order, the SAO shall issue a Lottery License as set out in Schedule C of this By-law.

2.4 A complete statement of account, showing the total receipts expenses and profits and indicating when and how such profits will be spent for the charitable or religious objects of purposes set out in the application, shall be filed with the SAO within 30 days of the holding of any lottery in the form marked at Schedule D.

2.5 The SAO may revoke the Lottery License issued under this By-law where he/she is satisfied that:

2.5(a) The License was issued in error whether due to misrepresentation or otherwise;

2.5(b) The Licensee has breached the conditions of the License;

2.5(c) The Licensee has violated the provisions of this By-law, or other applicable statutes or regulations.

2.6 Council may, by resolution, establish guidelines to assist with the administration of this By-law and such guidelines shall become those additional terms or restrictions the Hamlet may impose on any license in addition to those noted in the Terms and Conditions Respecting Lottery Licensing in Nunavut.

2.7 The SAO shall cause to be kept a record of all applications for the lottery licenses and all lottery licenses issued by the Hamlet.

2.8 Notwithstanding Section 2, for any Lottery Scheme within the Municipality of Kugluktuk, whereby a Lottery License for such scheme was issued by the Government of Nunavut prior to December 1, 1999 shall not require a Lottery License pursuant to this By-law.

2.9 Every person who contravenes any provision of this By-law is guilty of an offence and is liable upon summary conviction to:

2.9(a) for the first offence, to a fine not to exceed Five hundred (500.00) dollars, and,

2.9(b) for each subsequent offence, to a fine not exceeding Two Thousand (2000.00) dollars.


